- Brownfield Assessment Grant Announcement
 - Bywater informed the Group that there will be a check presentation of \$500,000.00 by the EPA to SCD for the Brownfield Grant. The Region 7 EPA Director and others from the State and DED will also be present. The presentation will be July 24th at 11:00 at the former Powerhouse Building
- Downtown Mural
 - Rocha presented a concept for a new mural on the north side of the El Paisano Building that will replace the existing Oregon Trail mural. Discussion was had and the wording of the mural was agreed upon to say "Hello from Schuyler". Funding would come from the Pathway Account. Motion to Approve by Lanuza. Seconded by Hoffart.
