Economic Development – Bywater, Rocha

- Mid-Winter Leadership Summit Feb. 16, 2024 Postponed
 - Will be rescheduled sometime in the future
- Adopt-a-Pot
 - O Rocha indicated that all of the 20 pots have been committed to businesses. Most of the \$250.00 annual pot adoption cost has been collected. Funds for the primary sponsorship of the program have been collected from Homestead and Pinnacle Banks. Still waiting on CHI Health and Center for Rural Affairs. The vegetation and care will be provided by the SCHS Horticulture class. An MOU is in development with the City to provide water and related labor for each pot

Railside Green

 Bywater is working with the Nebraska State Forest Service and Nebraska Statewide Arboretum to host a tree-trimming and plant care seminar to be held at the Ballroom on March 14th. The cost to attend is \$20 and the seminar runs from 9:00 to 3:00. There will be a hand's-on portion at Railside Green following the program

Top Notch Activity

 Bywater met with two individuals about the building and toured the facility. Both have plans for ground floor businesses. Will continue discussions. The Mayor has given a timeline for the end of the fiscal year to decide between sale and demolition. De Roos indicated advertising attempts to sell will be made via Internet outlets

Administrator Meetings

 Bywater informed the group that he has initiated weekly meetings with De Roos for communication with City Hall and visa-versa

NPPD Community Guide

 The biennial information guide is produced in partnership with NPPD and Loup Power. NPPD produced the guide at no cost to Schuyler and is added to their website. The guide will be completed in May

Housing - Bywater

- Water Tower 5th Subdivision Plat Update
 - Passed City Council on February 20th. Infrastructure bids will be let and planned approval is by June 1st. Substantial completion of infrastructure is planned for December 1st
- Proposed Tax Credit Project
 - Bywater and guest Kelby Herman provided information about another LIHTC project like Kracl Meadows. The planned project would have 20 units for people 55 and older. Motion to Approve working with Mesner Development to submit an application to DED for trust funds to construct at LIHTC project made by Heavican. Seconded by Hoffart. Motion Carried.
- Naming of the Mares Subdivision
 - o Bywater asked the group for name ideas for the new subdivision
- Approval of the Preliminary Plat
 - Motion to approve the preliminary plat provided by JEO and recommend approval to the Schuyler Planning and Zoning Commission. Moved by Renteria. Seconded by Arizmendi. Motion Carried.
